

## Privacy Policy

Since **2bcloud** ("**Company**") respects the privacy of the users of the websites it manages and operates, the Company has decided to publish its privacy protection policy on the websites, and it undertakes towards the user to comply with this policy.

## Transfer of information

## Disclosing information to a third party

If you purchase products and services from third parties that offer them for sale through the websites, these third parties will be provided the information required to complete the purchase process.

## Cookies

The Company's website uses "cookies" for the purposes of its regular and proper operation, including to collect statistical data about the use of the website, to verify details, to adapt the website to your personal preferences and for information security purposes.

Modern browsers include the option of refraining from receiving cookies. If you do not know how to do this, check the help file of the browser you are using.
